The following committees have open membership and are not limited to the number of members who can serve on them:

**Convention Committee.** Responsible for the annual convention programming and promotion. Members proctor the continuing education classes, assist convention rookies, and seek out contributors and exhibitors.

**Equal Opportunity/Cultural Diversity Committee.** Assists local REALTOR® boards, brokers, & salespersons in affirming and demonstrating a commitment to equal professional service. This is done through creating educational programs and materials and working with other like-minded organizations to offer education.

**Forms Committee.** This committee reviews and creates forms necessary in the real estate transaction.

**Governmental Affairs.** Monitors legislation introduced impacting the real estate industry and private property rights. Members are also involved in grassroots efforts to pass legislation working with their elected representative on issues.

**Participation Committee.** This Committee is charged with increasing member participation in the Association.

**License Law Committee:** This committee focuses on license law issues and interfaces with the Nebraska Real Estate Commission.

**Pathways to Professionalism Committee.** This committee's responsibilities include developing educational tools to assist members in presenting a professional image in their dealings with customers, clients, and other real estate professionals.

**REALTOR® Champion.** Members assist the Association in contacting their state senator on legislative issues that affect the real estate industry.

**Statewide Professional Standards Review Committee.** The members of this committee aid in the interpretation of the Code of Ethics through the development of education and printed materials. The committee oversees the Code of Ethics and Arbitration hearing procedures.
