



Ombudsman Process



The definition of Ombudsman for Realtors® – The Ombudsman Program in its simplest definition is informal telephone mediation. In some cases it can address and solve minor complaints from the public. It can also solve inter-Realtor® conflicts before they become serious problems. Like a mediator, an ombudsman helps parties find solutions.

WHAT IS THE NRA OMBUDSMAN Program?

Ombudsman Procedures adopted by the Nebraska REALTORS® Association (NRA) are intended to provide enhanced communications and initial problem-solving capacity to the professional standards process. NRA is charged with the responsibility of receiving and resolving ethics complaints, and hearing arbitration disputes filed against its' members. An Ombudsman can respond to general questions regarding real estate practices, transaction details, ethical practices and enforcement issues.

HOW WILL I KNOW TO ASK FOR AN OMBUDSMAN?

Many complaints do not expressly allege violations of specific articles of the REALTOR® Code of Ethics and may not concern conduct related to the Code. Some complaints are transactional, technical, and procedural questions that can be readily responded to. Some complaints are due strictly to lack of communication. These types of issues may be appropriate for the Ombudsman program.

WHAT ARE REALTOR® OMBUDSMAN BENEFITS?

You can receive non-judgmental real estate related information in a timely manner and at no cost.

WHAT THE OMBUDSMEN WILL NOT DO?

- Adjudicate/make the final decision;
- Give legal advice;
- Determine who is right or wrong;
- Disclose communications – Process is CONFIDENTIAL;
- Make any written record of discussions and/or agreements.

WHAT THE OMBUDSMAN WILL DO?

- Remain Independent - Ombudsman are independent from other Organizational entities;
- Remain Impartial - each of our Ombudsman will strive for impartiality, fairness, and be objective in their treatment of people and consideration of the issue;

- Remain Informal - Our Ombudsman will listen, provide and receive information, identify and reframe issues and engage in informal third party intervention.

WHO ARE THE OMBUDSMEN?

REALTORS® appointed by the Ombudsman Committee and meet the following criteria:

- Agree to serve for a 2 year term;
- Is a member of the National, State, and Local Association;
- Has 5 or more years of REALTORS® experience;
- Demonstrates objectivity;
- Received Professional Standards, Code of Ethics and Ombudsman training; and
- Possess extensive knowledge of the REALTOR® Code of Ethics, license law and best practices.

HOW DOES THE OMBUDSMAN PROCESS WORK?

The NRA Professional Standards Administrator aka Administrative Director will gather the information to be sent to the Ombudsman via e-mail. This information may include:

- Name, phone number and role of the complainant (that is, buyer, seller, broker, etc.)
- Name, phone number, and role of the respondent (that is, broker, principal broker, etc.)
- If the respondent is a broker, the name of principal broker and/or managing broker.

The NRA Ombudsman will make all necessary contacts in an attempt to resolve the complaint. If the Ombudsman efforts are effective, there is no further action necessary. If the efforts are not successful in resolving the Complainant's issues, the Ombudsman will advise the Complainant about the next step(s) in the complaint process.
